Important Notice for the RiverStone, Quality Inn, Courtyard, and LaQuinta Inn:

Tennessee Tax Exemptions must be approved in advance.

With a valid State of TN tax exemption status, state tax of 9.75% is exempt; however, local occupancy tax of 2.5% is not exempt.

All tax exemptions must be pre-approved prior to arrival.

Once approved, payment **MUST BE MADE** by check or credit card with the same name of the organization that is stated on the Tax Exemption certificate. If you pay by credit card, a copy of the credit card must accompany the tax exemption certificate. Personal funds cannot be accepted for tax exempt status (cash, personal credit cards, and/or personal checks).
